# SUPPLEMENTAL PROTECTIVE COVENANTS FOR DOWNEY KNOLLS RESIDENTIAL SUBDIVISION

#### **SECTION 3**

THIS SUPPLEMENTAL DECLARATION, made this 26th day of March, 2015, by BBWL, LLC, a Virginia limited liability company, hereinafter referred to as "Declarant", Grantor.
